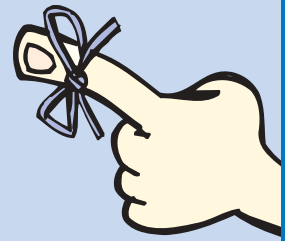

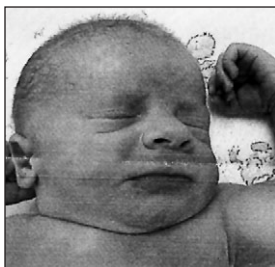
Clyde Charles Tressler, Jr.

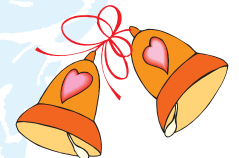

Bester, Joseph: His daughter, **Joanne Sanford**, writes:

"On March 11, 2004 my father, Joseph Bester went to be with the Lord. He was 90 years old. We brought him to live with us July 7, 2003 when my dear friend **Mary Rakas** developed a rare cancer and could no longer check in on my father. We had my father taken back to Cardale, Pennsylvania to be buried next to my mother who passed away 31 years ago. My father believed that marriage was forever and someday they would meet in heaven.

"About 40 years ago my father had a serious mine accident. The coal cutting machine that he was operating went haywire and through him against a wall. The machine was coming toward him so he braced himself with his right side out as far as he could stretch. In a voice as loud as he could yell he said: "Jesus, Mary and Joseph please, please help me". At that very second the power went off in the coal mine. Even though he sustained serious injuries and was



out of work for several months it was his undying faith that saved him. Not once did he complain during his recuperation period. I can still remember him whistling his polkas as he got from the back of the house to the front on crutches. It took a lot of courage for him to return to the coalmines. Upon his return they made him the mine safety inspector. This is how I would like my father remembered as a man of deep faith, a heart filled with love, and a man of tremendous courage.”

Product Review: *Movin’ and Groovin’ Fitness for Kids*

As many of you know, I have lost 115 pounds over the last couple of years. I have been obese most of my life and when I turned 30 in 2002, I decided enough was enough and made the necessary changes in my lifestyle to trim down from 325+ lbs to about 210 lbs today. 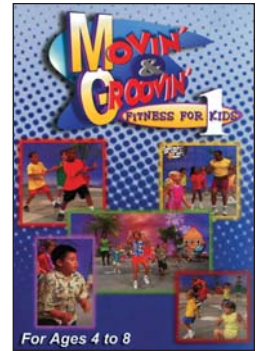
With that being said, I was more than casually interested when I met Mike Schwartz at a hockey game earlier this season. He told me that he, too, had lost over 100 pounds. In addition, he told me that his youngest son, Austin, has struggled with his weight. This really struck a nerve with me, because I don’t ever want either of my two sons to be overweight. Austin looks like a normal, healthy, teenager now, so I was keenly interested to hear his story.

In 1997, Austin was 8 years old, chubby, and getting teased a lot at school. He tried dieting (starvation) on his own with no luck. Mike & Janine took him to a doctor to see if there was any physical reason for his excessive weight. The doctor simply stated that he needed aerobic exercise—which is not the same as activity. For example, your child might be active in Little League Baseball, but spend only couple minutes per game actually running or moving vigorously.

Janine tried to enroll Austin at a gym, but found a minimum age requirement of 14. Next she tried exercise videotapes, such as Richard Simmons, Jane Fonda, etc. But the routines were too long, complex, and difficult for children, and Austin would often cry in frustration. She said to herself, “Someone needs to make a video for kids!” More than a year later, she did.

Janine hired an aerobics instructor and a personal trainer to develop routines and lead them in the video. She hired a production company to compose songs with healthy messages kids about brushing your teeth, doing chores, hygiene, hard work, etc.

I have watched this video and I think Mike & Janine did a terrific job. The sets are colorful, the music is catchy, and the kids on the video really look like they’re having fun.

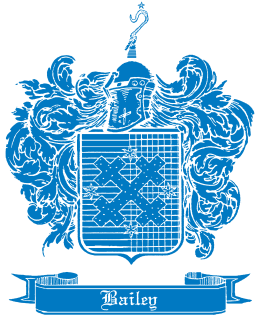
